Mr. Hansen:

Rice Operating Company (ROC) is the service provider (agent) for the EME Saltwater Disposal (SWD) System and has no ownership of any portion of the pipeline, well, or facility. The System is owned by a consortium of oil producers, System Parties, who provide all operating capital on a percentage ownership/usage basis.

#### **Background**

In 2001, ROC initiated work on the former B-6 junction box. The site is located in UL/B, Sec. 6, T20S, R37E. NM OSE records indicate that groundwater would likely be encountered at a depth of approximately 28 +/- feet. After the junction box was removed, the site was delineated using a backhoe to collect soil samples at regular intervals, creating a 27x15x13 ft deep excavation. Each sample was field titrated for chlorides, resulting in low concentrations. Representative composite samples of the excavation bottom and the excavation walls were sent to a commercial for analysis of chloride and TPH, resulting in a sidewall chloride concentration of 136 mg/kg and concentrations of gasoline range organics (GRO) and diesel range organics (DRO) below detectable limits. The bottom composite resulted in a chloride concentration of 35 mg/kg, a GRO concentration below detectable limits and a DRO concentration of 43 mg/kg. The remediated soil was returned to the excavation to 3 ft below ground surface (bgs). From 3 – 2 ft bgs, a one foot thick clay layer was installed. The remainder of the excavation was backfilled with clean soil to ground surface and contoured to the surrounding area. A new, water-tight junction box was previously built over the same location.

The junction box site location map, final report, laboratory analysis, disposal manifests and current photodocumentation are attached.

#### Recommendations

Site investigation demonstrates that residual chloride and hydrocarbons in the vadose zone will not with reasonable probability contaminate groundwater in excess of NMOCD standards. This site meets the requirements of the NMOCD-approved Revised Junction Box Upgrade Work Plan (July 16, 2003). As such, ROC request termination of the regulatory file, or similar closure status.



Site Location Map


