

Describe Cause of Problem and Remedial Action Taken.*: Furgesson construction was excavating for new pipeline. At this time they hit a 2" Fiberglass injection line. The line was under pressure but was originally feeding Keel B #39, a plugged and abandond well. Line was shut in and vaccum truck was called. Vaccum truck picked up approximatly 5BBL.		
Describe Area Affected and Cleanup Action Taken.*: Area affected was inside ditch from pipeline excavation. It covered an area 4' by 30'. Leak site was approximatly 80' from dry hole marker.


