Production separator water dump malfunction allowing water to exit vessel with oil product to the sales oil tank/s which filled, overflowing into our secondary containment area. A small amount ran over to the immediate area next to our secondary containment but stayed within our facility boundary.

Describe Area Affected and Cleanup Action Taken.*

Water dump was fixed and vacuum trucks were immediately brought in to recover all available product back to our oil storage tank/s. Once free liquid is picked up the area will be remediated as per requirements.
