

The buried fiberglass line fractured due to traffic. The line has been replaced and added more surface material for additional padding and protection.					
Describe Area Affected and Cleanup Action Taken.*					
Initially an estimated 10bbls were released due to a fracture in a buried fiberglass line on location. We were unable to recover any fluids. The entire spill was contained on the location. Tetra Tech will sample the spill site area to delineate any possible contamination from the release and we will present a work plan to the NMOC D/BLM for approval prior to any significant remediation work.
