Dear Ms. Bailey:

Encana Oil & Gas (USA) Inc. (OGRID No. 282327) hereby seeks administrative approval pursuant to the provisions of Division Rule 19.15.15.13 NMAC for an unorthodox well location for its Meadows I08-3014 1H well located in the S/2 of Section 8, Township 30 North, Range 14 West, N.M.P.M., San Juan County, New Mexico. This well has been drilled and was initially permitted by Division first as an oil well in the Greek Gallup pool, and then as a wildcat well in the Gallup oil well. *See Exhibit A* (C-102s filed 11/3/11 and 3/12/12). Encana has now been informed by the Division's district office that under Order R-12984, this well is in the Basin Mancos Gas Pool governed by Special Rules requiring 320-acre spacing units and wells to be located no closer than 660 feet to the outer boundary of the spacing unit. Since the bottom-hole for this existing well is located only 356 feet from the West line of Section 8, Encana requires an exception to Rule 2.C(1) of the Special Rules for the Basin Mancos Gas Pool before it can re-dedicate the S/2 of Section 8 to this horizontal well.

Exhibit B is the Amended Form C-102 for this well that Encana intends to file with the Division. It reflects that the location of this existing well complies with the location requirements of the Basin Mancos Gas Pool except for the bottom-hole location, which encroaches on the offsetting spacing unit in Section 7.

Exhibit C is a plat showing the leases in Sections 7 and 8. It reflects that Encana and Dugan Production Corporation are the lessees for Federal Lease NM 16765 and the offsetting fee leases in Section 7.

Exhibit D is a list of the mineral owners in the fee leases located in Section 7. Each of these mineral owners, as well as the BLM, have been provided notice of this application and informed that if they object to this application, a written objection must be filed with the Division within twenty days of the date of this application.

Approval of this unorthodox well location is necessary to comply with the Division's requirement that this well be permitted in the Basin Mancos Gas Pool and to allow for the most efficient horizontal well development pattern in the S/2 of Section 8. Your attention to this application is greatly appreciated.





This change is due to revised New Mexico Oil and Gas Regulations that became effective on February 15, 2012 that limit project areas to contiguous spacing units penetrated by the well bore.


As a result of the project area dedication, Encana has revised the well bore to satisfy setback requirements. Revising the well bore results in the following changes:

* Plug A of the vertical hole needs to be expanded to 100' above the Graneros formation top *
Proposed Wellbore TD is 5111' TVD/9585' MD (original approval was 5108' TVD/9519' MD)
Proposed KOP is 4490' TVD/MD (original approval was 4571' TVD/MD)
Proposed lateral is 4101' (original approval was 4043')
Proposed Gallup Penetration Point is 321' FEL (original approval was 400' FEL) and proposed top of completed interval is 623' FEL.

A revised C-102, 10-Point Drilling Plan, Wellbore Schematic, and Directional Plans are attached.
