





Dear Mr. Jones:

Mesquite SWD, Inc. respectfully requests your consideration of the attached information to support a request for Administrative approval of a pressure increase from the present 883 psi surface pump pressure to a new level of 1,400 psi. The increased pressure is necessary to overcome lower actual disposal depth and handle increased disposal requirements.

The formation open hole interval is 4,550' to 6,140' with 3-½" tubing and packer set in casing at 4,530'. Note: The OCD permitted interval was greater on top and bottom than the actual interval completed because Mesquite reduced the open hole interval to satisfy COG protest.

Inclosed is a Cardinal Step Rate Test dated February 28, 2013.
