

Describe Cause of Problem and Remedial Action Taken.\*

High volume of produced water and alarm levels set too high. Called haul trucks and lowered alarm levels.

Describe Area Affected and Cleanup Action Taken.\*

Initially 36bbls of produced water were released due to high produced water volumes and the alarms were set too high. We were able to recover 35bbls produced water with a vacuum truck. The spill was completely contained inside the lined facility walls. All free fluid has been recovered. Any contaminated gravel has been removed, the liner has been steam cleaned, and we have replaced with fresh gravel as necessary. This facility has been returned to its prior condition.
