


If a Watercourse was Impacted, Describe Fully

Describe Cause of Problem and Remedial Action Taken.* A 4" steel flow line leaked causing a release of approximately 300 bbls of produced water. The flowline was taken out of service, repaired and put back into service. A vac truck was called to the location and 120 barrels of produced water was recovered. The impacted area measured approximately 300'x300'.

Describe Area Affected and Cleanup Action Taken.* Talon/LPE was contracted to complete the site assessment to determine appropriate clean up actions. On March 27, 2013 Talon personnel mobilized to begin the site assessment and soil sampling activities for the above referenced location. Grab soil samples were collected from the surface of the impacted area and sent to Cardinal Laboratories for analysis. Analytical testing results are attached, along with a site map for the impacted area. The impacted area test results are under is under the Recommended Remedial Action Levels (RRAL). The New Mexico State Engineer web site indicates the nearest ground water data to be in S26-T21S-R24E. The ground water in the area is reported to be 150' below ground surface (bgs). The referenced groundwater data is also attached. We request that no further actions are required.

I hereby certify that the information given above is true and complete to the best of my knowledge and understand that pursuant to NMOCD rules and regulations all operators are required to report and/or file certain release notifications and perform corrective actions for releases which may endanger public health or the environment. The acceptance of a C-141 report by the NMOCD marked as "Final Report" does not relieve the operator of liability should their operations have failed to adequately investigate and remediate contamination that pose a threat to ground water, surface water, human health or the environment.
