Pursuant to your application received on May 15, 2013, BOPCO, L.P. (OGRID 260737) is hereby authorized to surface commingle gas production only from the following pools located in Eddy County, New Mexico.

The Poker Lake Unit wells produce only from Northeast Coral Canyon Delaware Pool. The PLU Big Sinks wells will produce only from the Bone Spring. No downhole commingling is authorized.

The commingled gas production shall be measured and sold at the Poker Lake Unit No. 42 Battery in Section 10-25S-30E, Eddy County. Production will be allocated to the Poker Lake Unit Wells No. 42 and 79 based on wells tests. The remaining three wells shall each be separately metered. Meters shall be calibrated in accordance with Rule 19.15.12.10.C(2)(b).

The operator shall notify the transporter of this commingling authority.

The operator shall notify the Artesia district office of the Division upon commencement of commingling operations.

This approval is subject to like approval from the United States Bureau of Land Management and the New Mexico State Land Office before commencement of the commingling operations.
