You have requested to drill or re-complete this well at an unorthodox oil well location described above, in the referenced pool or formation. This location is governed by statewide Rule 15.9.A [19.15.15.9.A NMAC], which provides for 40-acre units, with wells located at least 330 feet from a unit outer boundary. Due to the irregular shape of this section the proposed bottom hole location is less than 330 feet from the south and west unit boundaries of the unit.
