Describe Area Affected and Cleanup Action Taken.* Initially an estimated 100bbls of produced water was released due to a Victaulic clamp that failed. We were unable to recover any fluid. The spill area is located in the pasture. Tetra Tech will sample the spill site area to delineate any possible contamination from the release and we will present a work plan to the NMOCD for approval prior to any significant remediation work.
