Pursuant to Division Rule 19.15.15.13, Apache Corporation ("Apache") respectfully requests administrative approval of an unorthodox oil well location for its proposed A State No. 55. This well will be drilled as a development oil well in the Artesia Glorieta-Yeso Pool (96830).

The proposed A State No. 55 will be dedicated to an existing 40-acre spacing and proration unit in the Artesia Glorieta-Yeso Pool comprising the SW/4 NW/4 of Section 26. This unit is currently dedicated to Apache's: i) proposed A State No. 43 (API No. 30-015-38546) located at an unorthodox well location 2310 feet from the North line and 1120 feet from the West line; ii) proposed A State No. 45 (API No. 30-015-41147) located at a standard well location 1650 feet from the North line and 990 feet from the West line; and iii) existing A State No. 56 (API No. 30-015-38965) located at a standard well location 1650 feet from the North line and 330 feet from the West line.

The Artesia Glorieta-Yeso Pool is currently governed by Division Rule 19.19.15.9 which requires standard 40-acre oil spacing and proration units with wells to be located no closer than 330 feet to the outer boundary of the spacing unit.

The proposed unorthodox well location is necessary in order to avoid an existing well and well pad.

The affected offset tracts are the NW/4 SW/4 of Section 26 and the NE/4 SE/4 of Section 27, both in Township 17 South, Range 28 East, NMPM. The NW/4 SW/4 of Section 26 is currently being developed in the Artesia Glorieta-Yeso Pool by numerous

wells operated by Apache. Please note that the working interest ownership between the drill tract and the NW/4 SW/4 of Section 26 is common. The leasehold owner of the Artesia Glorieta-Yeso Pool within the NE/4 SE/4 of Section 27 is Occidental Oil & Gas Corporation. Notice of this application is being provided to Occidental Oil and Gas Corporation in accordance with Division rules.

Attached is a Form C-102 showing the proposed well, spacing unit and other existing and proposed wells in the spacing unit. Also attached is a map showing the affected offset acreage, a vicinity map and notice letter.

In summary, approval of the application will provide Apache Corporation the opportunity to recover additional oil and gas reserves from the Artesia Glorieta-Yeso Pool underlying the SW/4 NW/4 of Section 26 that may otherwise not be recovered by the existing and proposed wells, thereby preventing waste, and will not violate correlative rights.





Affected Offset Acreage




