Pursuant to NMAC 19.15.15.11 and 19.15.15.13, Mewbourne Oil Company applies for approval of a non-standard gas spacing and proration unit in the Wolfcamp formation, and an unorthodox gas well location, for the following well:

<u>Well:</u>	San Lorenzo 22/27 LE Well No. 2H
<u>Surface location:</u>	2260 feet FSL & 760 feet FWL of Section 22
<u>Bottomhole location:</u>	2310 feet FNL & 660 feet FWL of Section 27
<u>Well unit:</u>	SW $\frac{1}{4}$ of Section 22 and NW $\frac{1}{4}$ of Section 27, Township 25 South, Range 28 East, N.M.P.M., Eddy County, New Mexico

Applicant is 100% working interest owner of the non-standard unit, and desires to drill the well on a 100% basis. The Wolfcamp formation (wildcat) is developed on statewide rules, with 320 acre spacing and wells to be located no closer than 660 feet to a quarter section line. 


