



Endurance Resources, LLC. ("Endurance"), has plans to do a lateral extension in the Second Bone Spring interval in the above referenced well. The above referenced location is closer to the section line than is prescribed for the Bell Lake Bone Spring Pool (Pool 5130) which provides for locations to be no closer than 660 feet from the section line. Devon Energy Production Company, L.P., as operator of the SW/4 of Section 17 and the SE/4 of Section 18, both sections being located in T23S, R34E, Lea County, NM, may object to Endurance's well location due to the bottom hole location of the above referenced well being too close to the lease line per the rules of the Bell Lake Bone Spring Pool (Pool 5130). Objections must be filed in writing within twenty of receipt at the Division's Santa Fe office. If no objection is received within this twenty-day period, this application for an unorthodox well location may be approved.
