An approximate area of 50' X 75' (north side of production pad) and an approximate area of 50' X 50' (west side of production pad). Production pad will be scraped; impacted soils will be taken to an NMOCD approved facility. Vertical and horizontal delineation samples outside of battery will be taken and analysis ran for TPH & BTEX (chlorides for documentation). If initial analytical results for TPH & BTEX are under RRAL's a Final Report, C-141 will be submitted to the OCD requesting closure. If the analytical results are above the RRAL a work plan will be submitted to the OCD. **Depth to Ground Water: >100' (approximately 325', per the ChevronTexaco Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: > 1000', SITE RANKING IS 0.**
