

Describe Cause of Problem and Remedial Action Taken.*
High pressure and heat caused a poly flow line to rupture in a weak spot in the line, causing fluid to leak on to the lease road. The leak was isolated upon discovery and the poly line was fixed.

Describe Area Affected and Cleanup Action Taken.*
An approximate area of 10' X 200' (release was on the lease road. Some overspray affected a few mesquite bushes). The lease road will be scraped and the mesquite bushes will be sprayed with 8% microblaze upon one-call clearance. **Depth to Ground Water: >100' (approximately 250', Section 6, T25S-R30E, per Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 0. Based on release occurring on the lease road and the small amount released, Yates Petroleum Corporation requests closure.**
