A 4 inch poly flowline was damaged when CVE Electric Co. drilled to place a power pole and drilled through the line. The volume of the leak was 3 bbls of oil and 12 bbls of produced water. Talon/LPE was contracted to perform an initial site assessment and soil sampling. Upon receipt of analytical results from the soil sampling activities a work plan will be drafted and remedial activities will begin upon its approval.

Describe Area Affected and Cleanup Action Taken.*

The affected area is approximately 40' X 20'. This area includes impacts on the location and pasture land.
