

Describe Cause of Problem and Remedial Action Taken.*

A sixteen (16)-inch low pressure steel natural gas pipeline developed a leak, resulting in a release of natural gas, crude oil and produced water. During initial response activities the pipeline was clamped to mitigate the release. The affected steel pipeline segment will be replaced at a later date. BLM (Legion Brumley - ROW) was notified of the release on November 2, 2012 at 1658 hours.

Describe Area Affected and Cleanup Action Taken.*

An area along the pipeline ROW measuring approximately 20 feet in width and 50 feet in length was impacted by the release. In addition, a low lying area north of the release site measuring approximately 1 to 3 feet in width and 200 feet in length was impacted by the pipeline liquids. The BLM has requested an Archaeological Survey be conducted in the affected area prior to remediation activities. After receiving permission from the BLM to commence remediation, Southern Union will remediate the release to the proper NMOCD and/or BLM guidelines.

I hereby certify that the information given above is true and complete to the best of my knowledge and understand that pursuant to NMOCD rules and regulations all operators are required to report and/or file certain release notifications and perform corrective actions for releases which may endanger public health or the environment. The acceptance of a C-141 report by the NMOCD marked as "Final Report" does not relieve the operator of liability should their operations have failed to adequately investigate and remediate contamination that pose a threat to ground water, surface water, human health or the environment.
