Describe Cause of Problem and Remedial Action Taken
 Leak was reported to Enterprise by rancher at 9:30 a.m. (Mountain) on 8-22-2011. Leak was reported off C.R. 31 north of London Road, technician and supervisor went to locate to confirm leak. Minor Leak was confirmed to be on Enterprise's 12" Donaldson line at T-23S, R-28E in section 23 in Eddy county Carlsbad New Mexico. This line is a low pressure line. The line is a non-jurisdictional, no fire, no injuries and approx. 20 gals of bs&w stain on ground which will be cleaned up at repair of leak. Leak will be excavated and clamped. Total gas loss due to leak was estimated at, 650 mcf and 60 mcf to blow line down.

Describe Area Affected and Cleanup Action Taken
 A standard one-call will be initiated to expedite repairs. Gas flow to the line was shut in. A clamp will be used to safely perform the repair and the line will be brought back to normal operation. Producers were notified of shut in, there were four wells shut in due to leak. Estimated gas loss .650 MMscf, anticipated gas loss due to pipeline leak and 0.060 MMscf due to pipeline blow down to perform safe repairs. Total 0.710 MMscf sweet natural gas.
