WHEREAS, CARL R. - (1) the oil, gas and mineral leases and leasehold estates described in Exhibit "A" attached hereto, together with any and all overriding royalty interests, production payments or other interests in the production of oil, gas or other minerals in, under or that may be produced from the lands covered thereby ("Leases");
- (2) any presently existing and valid farmout agreements, pipeline agreements, gas contracts, transportation agreements, oil and condensate purchase agreements, division orders, pooling and unitization agreements, joint operating agreements and other contracts or agreements to the extent same cover and affect the herein described Leases ("Agreements");
- (3) all equipment, personal property, fixtures and improvements of any kind or character situated upon, appurtenant to and/or used or held for use in connection with the production, treatment, storage and/or transportation of oil, gas, casinghead gas or other liquid or vaporous hydrocarbons from the herein described leases ("Improvements"); and

This agreement shall inure to the benefit of and be binding upon the parties hereto, their respective heirs, legal representatives, successors and assigns.


