

Stuffing box leak on the well head due to back pressure. We have repacked the stuffing box.					
Describe Area Affected and Cleanup Action Taken.*					
Initially 2bbls of oil and 6bbls of produced water were released due a packing leak on the stuffing box. We were able to recover 1bbls of oil and 4bbls of produced water with a vacuum truck. The spill was contained on the location. All free fluid has been recovered. Tetra Tech will sample the spill site area to delineate any possible contamination from the release and we will present a work plan to the NMOCD - BLM for approval prior to any significant remediation work.


