

Pipe stress and high pressure caused a hole in the poly line causing it to break off. Supported line better and lowered pressure.					
Describe Area Affected and Cleanup Action Taken.*					
Initially 80bbbls of produced water were released due to a poly line failure caused by stress and high pressure. We were able to recover 75bbbls of produced water with a vacuum truck. The entire release was contained inside the lined facility. All free fluid has been recovered. Contaminated gravel has been removed and we have replaced with fresh gravel as necessary. This location has been returned to its prior condition.
