Pursuant to Division Rule 104.F(2), Bass Enterprises Production Co. applies for approval of an unorthodox oil well location for the following well:

<u>Well:</u>	Poker Lake Unit Well No. 254
<u>Location:</u>	330 feet FNL & 1160 feet FEL
<u>Well unit:</u>	NE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 31, Township 24 South, Range 30 East, N.M.P.M., Eddy County, New Mexico


The well will be drilled to a depth sufficient to test the Delaware formation. The formation is spaced on statewide rules, with 40 acre spacing, and wells to be located no closer than 330 feet to a quarter-quarter section line. A Form C-102 for the well is attached as Exhibit A.

The location is based on topographical reasons. The proposed location is immediately near an existing lease road and pipeline, which minimizes surface disturbance, as required by the Bureau of Land Management. In addition, the southern portion of the well unit drops off to an arroyo. See Exhibit B.

The well is located on Federal Lease LC 069627-A, which covers all of Sections 30 and 31. Because the lease has common ownership, there is no adversely affected party, and notice has not been given to anyone.






THE POKER LAKE UNIT No. 254 LOCATED 330' FROM






