Pursuant to Division Rule 19.15.15.13, Apache Corporation ("Apache") respectfully requests administrative approval of an unorthodox oil well location for its proposed AAO Federal No. 24. This well will be drilled as a development oil well in the Northeast Red Lake Glorieta-Yeso Pool (96836).

The proposed AAO Federal No. 24 will be dedicated to an existing spacing and proration unit in the Northeast Red Lake-Glorieta-Yeso Pool comprising the NE/4 NE/4 of Section 1. This unit is currently dedicated to Apache's existing AAO Federal No. 4 (API No. 30-015-32310) located at a standard well location 990 feet from the North and East lines of Section 1.

The Northeast Red Lake Glorieta-Yeso Pool is currently governed by Division Rule 19.19.15.9 which requires standard 40-acre oil spacing and proration units with wells to be located no closer than 330 feet to the outer boundary of the spacing unit.

The proposed unorthodox well location is necessary in order to avoid a deep ravine within the drill tract. The BLM requested that Apache move the location from a standard well location to the proposed location in order to avoid this surface obstruction.

The affected offset tracts are the NW/4 NW/4 and SW/4 NW/4 of Section 6, Township 18 South, Range 28 East, NMPM. There is currently no development in the Glorieta-Yeso interval on the two affected offset tracts. The leasehold owners within the NW/4 NW/4 of Section 6 include ZPZ Delaware I, LLC, an Apache entity, and Occidental Permian Limited Partnership. The leasehold owner within the SW/4 NW/4 is

ConocoPhillips Company. In accordance with Division rules, Apache is providing notice of this application to Occidental Permian Limited Partnership and ConocoPhillips Company.

Attached is a Form C-102 showing the proposed well, spacing unit and the other existing well in the spacing unit. Also attached is map showing the affected offset acreage, a vicinity map, and notice letter.

In summary, approval of the application will provide Apache Corporation the opportunity to recover additional oil and gas reserves from the Northeast Red Lake Glorieta-Yeso Pool underlying the NE/4 NE/4 of Section 1 that may otherwise not be recovered by the existing or proposed wells, thereby preventing waste, and will not violate correlative rights.





Affected Offset Acreage




