

An approximate area of 20' X 30'. Spill is approximately 200 yards north of cattle guard where CR29 intersects. The release occurred over the same area as a release from 8/17/2013 (this release was still in the process of being cleaned up). The release made a flow path on the east side of the lease road. The flow line valves were shut off, leak was isolated, and Dolores water pump was shut off. The line was repaired. Flow path on the east side of the lease road will be excavated. All excavated soils will be disposed of at an approved NMOCD facility. Vertical and horizontal delineation samples will be taken and sent to a NMOCD approved facility. **Depth to Ground Water: >100' (approximately 150', Section 11, T22S-R31E, per Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 0.**


