Describe Cause of Problem and Remedial Action Taken.* Approximately 10 Bbbls of Produced water was discovered spilled on the west end of the Remuda Basin SWD 1 facility under the H pump. The water also flowed onto the pasture on the west side of the site. Size of area affected: 42'x120'. Due to internal corrosion inside the 1/2 inch nipple, vibration from the pump weakened the nipple causing it to break off the suction line to the H pump. The burn on location was repaired and Globe Services recovered 4 Bbbls of the 10 Bbbls of spilled produced water via vac truck. Pump will be balanced to reduce vibration, two more braces will be installed to support discharge line and mounting brackets will be installed for the murphy switches on the pump.		
Describe Area Affected and Cleanup Action Taken.* Vac truck recovered 4Bbbls of the 10 Bbbls spilled. Talon LPE to gather soil samples for analyzing. Based on the soil sample results, the Bureau of Land management will make the determination regarding whether to remove and replace the affected soil or any other remedial actions necessary.
