Describe Cause of Problem and Remedial Action Taken.*
A 4" poly flowline leaking causing a release of approximately 70bbls of produced water. A vacuum truck was used to recover approximately 2bbls of fluid. Talon/LPE was contacted to conduct a site assessment and collect soil samples within the impacted area.

Describe Area Affected and Cleanup Action Taken.*
The affected area included the lease road adjacent to the release point and two flow paths into the pasture that traveled approximately 110' and 390' respectfully. Talon/LPE has been retained for assessment and remediation efforts at this location.
