**On May 12, 2014 the lease operator was doing his daily lease check and upon arrival he found about fifteen barrels of produced water had spilled to the ground. Lease operator said it happened sometime during the night. It was determined that packing from the jet pump was blown out of the pump causing produced water to overflow to the ground. The lease operator shut the pump off and called the assistant foreman that was in charge. Gandy was called at 9:30 am for vacuum services, a Weatherford representative was notified at 9:41am and Custom Welding was called at 9:43 am, for backhoe services. The BLM and the OCD was notified on May 13, 2014 at 7:31 am and 7:49 am respectively. The size of the spill area was about 150 feet by 60 feet. Approximately 10bbls were recovered from the ground.**
