

Water discharge poly line ruptured, valves were shut and vacuum trucks were called to vacuum up the spill, roustabout crew called to repair line, backhoe crew called to scrap up impacted soils on pad area (impacted soils taken to an NMOCD approved facility. Further excavation work to be conducted impacted soils will be taken to an NMOCD approved facility. Vertical and horizontal delineation samples outside of battery will be taken and analysis ran for TPH & BTEX (chlorides for documentation). If initial analytical results for TPH & BTEX are under RRAL's a Final Report, C-141 will be submitted to the NMOCD requesting closure. If the analytical results are above the RRAL a work plan will be submitted to the NMOCD. Depth to Ground Water: <50' (approximately 25'; per the ChevronTexaco Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 20.
