

**On August 5, 2014 at the Rio Blanco 4 Fed Com 3 SWD, a 1 inch valve on the bottom of a Y-strainer blew out resulting in approx. 20bbls of produced water to be released. Basic was called for vacuum services. Approximately 15 barrels of produced water were recovered.**

Describe Area Affected and Cleanup Action Taken.\*  
**The area affected was 24 feet wide by 64 feet long and was contained within the impacted area of the old release. Talon LPE was contacted to perform the site assessment which will be addressed along with the previous release on 6/19/2014.**
