

Describe Cause of Problem and Remedial Action Taken.\*

The packing in the stuffing box on the well head was compromised and leaked 15 bbls of oil and 20 bbls of produced water onto the ground. No fluids were recovered and the packing in the stuffing box was replaced.

Describe Area Affected and Cleanup Action Taken.\*

The affected area is approximately 150' x 40' both on and off location. The leak is mostly on the pad around and south of the well head with some overspray reaching into the pasture on the north side of the location. Remediation will be completed in accordance with a remediation plan approved by NMOCD and the BLM.

I hereby certify that the information given above is true and complete to the best of my knowledge and understand that pursuant to NMOCD rules and regulations all operators are required to report and/or file certain release notifications and perform corrective actions for releases which may endanger public health or the environment.
