

**Describe Cause of Problem and Remedial Action Taken.\***

A fire erupted from merphy switch boxes, catching the tanks on fire and causing the release. Emergency fire truck(s) and vacuum truck(s) were called.

**Describe Area Affected and Cleanup Action Taken.\***

Emergency fire trucks were called to extinguish the fire, and vacuum trucks were called to clean the spill and drain the tanks. All tanks located on the berm will be replaced. Vertical and horizontal delineation samples will be taken and analysis ran for TPH & BTEX (chlorides for documentation). If initial analytical results for TPH & BTEX are under RRAL's (site ranking is 10) a Final Report, C-141 will be submitted to the OCD requesting closure. If the analytical results are above the RRAL's a work plan will be submitted to the OCD. **Depth to Ground Water: >100' (approximately 310', per Chevron Texaco Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: 200-1,000', SITE RANKING IS 10.**
