Describe Cause of Problem and Remedial Action Taken.*
Hammer Union/Line developed a leak at the point where the line makes a 90 degree turn to the east going under Grandi Road. Upon discovery, the line was shut in and the impacted area was excavated to expose the line. Once exposed, the line was repaired and put back in service. The impacted soil that was excavated was transported to a division approved disposal facility. An environmental remediation company will be contracted for a complete remediation of the impacted area. During the remediation/excavation process, groundwater was encountered at approximately 12' BGS on the west side of the road. A groundwater sample was obtained and sent for lab analysis. Results will be presented to NM OCD.

Describe Area Affected and Cleanup Action Taken.*
