Describe Cause of Problem and Remedial Action Taken.*
A poly flowline, approximately 300yds west of the location developed a leak. The flowline transports produced water from the Britt Laughlin #6 to Rice Operating's disposal system header. The leak was discovered not long after it occurred resulting in a smaller spill foot print. Please see attached photos. No standing fluid was present therefore no fluid was recovered. The line was shut in and repaired immediately.

Describe Area Affected and Cleanup Action Taken.*
The total affected area is approximately An estimated 25bbls or less of produced water with traces of oil was leaked on to the location covering an area approximate of 30ft X 60ft or 1,800sq.ft. EnerVest environmental representative and an environmental consultant have visited the site to evaluate and develop a remediation plan. The remediation plan of choice is to conduct a sampling investigation and "dig and haul" operations, with contaminated soil being delivered to Lea Land Disposal.
