In consideration of the time between the release and the sampling event, the volume of unrecovered fluids, soil conditions at the site, and at least one significant rain event since the release, OCD would request deeper samples be obtained at (sample) Points 2,6,8,11 and 14. Depth should be in the 10' bgs range. The listed sample points should be tested for chloride content, with additional testing for hydrocarbons at (sample) Points 2,8 and 14. Additional testing may be required based on the results of analytical data from these sample points. This request is subject to BLM approval and/or agreement.
