Describe Cause of Problem and Remedial Action Taken.*

On July 24, 2014 a DCP pipeline repair crew was excavating and struck a four inch SWD poly line apparently belonging to Nearberg and approx. 17 bbls of oily salt water spilled into the excavation ditch. An 811 call was made but no one from Nearberg responded.

Describe Area Affected and Cleanup Action Taken.*

Upon discovery, the line was blocked in and a vacuum truck summoned to vac out the free liquid. A meeting at the site will be held on July 29, 2014 with Nearberg to discuss cleanup action. Nearberg claims they never received an 811 call as their Carlsbad office is not manned to receive calls.

Nearberg was not on the one call, No tracer wire or tracer tape was present. We contacted Nerberg to see if they wanted this at there disposal and they told us no.
