

Good Afternoon.

Briefly.....

A release of produced water occurred on Wednesday, October 22 from a flow line in section 4, T14S, R29E.

The water transfer was immediately shut-in and the flowline was promptly repaired.

About 75-80 bbls was released. The impacted area is about 50' x 40'.

Hand samples were taken to start determination of lateral and vertical extent.

Since the release area is within sand dune lizard and lesser prairie chicken habitat, no further actions have been authorized.

A BLM biologist and realty specialist are going to the visit the site on Friday, October 31.

The response actions required from Hunt Cimarron for further assessment and cleanup will be based on the BLM habitat assessment, which we will probably have completed early next week.
