Attached is the survey plat, topographic map, aerial photo map for the well listed above. As evident by the map attached Whiting requests the non-standard location exception due to the location of the playa lake in this section. Locating the well at the current flat surface location minimizes possible flash flooding problems, safer access for roads and pipelines and optimizes the use of existing county and lease roads. Whiting will drill this well with a surface temporary pit and that needs to be taken into account in relation to the existence and closeness of the playa lake.

The proposed well location is closer to the spacing units inside border. Whiting has leased all other affected spacing units within the section and all surrounding sections. Therefore there is no notification requirements. Please reference attached map.


