

Describe Cause of Problem and Remedial Action Taken.* <i>The DR-120-24V power supply that provides 24 VDC to the PLC failed and a loss of power occurred at the Todd 26G Fed 2 SWD that led to a spill of 45 bbls of oil. As a result of the power outage pumps and alarms lost power and communication with each other. The faulty unit was replaced and power was restored to the PLC.</i>		
Describe Area Affected and Cleanup Action Taken.* <i>A 60'x20' area of the pad at the Northwest side near the storage tanks inside the berm containment was affected by the spill requiring the aid of a vacuum truck provided by Standard Energy Services. 40 bbls of the 45 bbls of oil spilled were recovered. The contaminated caliche will be removed and replaced with clean caliche.</i>
