

**Due to downstream flow restrictions, Line 1002 line pressure built up causing the release of natural gas to the atmosphere from a pipeline overpressure protection valve. On arrival by Enterprise technicians, the valve had already closed. To avoid further pressure occurrences, operations personnel diverted the gas flow.**
