The release was caused by a failure in a broken 1/4 nipple on the tubing of the wellhead. Vacuum trucks were dispatched to recover all standing fluid.

Describe Area Affected and Cleanup Action Taken.*
This spill impacted a 40'x40' area. The portion of pasture impacted was treated with Microblaze and soapy water. Concho will have the spill site sampled to delineate any possible contamination from the release and we will present a remediation work plan to the NMOCD for approval prior to any significant remediation work.
