

The release was caused by a split on the weld of a 6" poly line. The split occurred on a Y that ties into the manifold and main system. Vacuum trucks were dispatched to recover any standing fluids.

Describe Area Affected and Cleanup Action Taken.*

The release originated behind the Ebony State #4. The impacted area is located from the battery due west approximately 800' down a power line right-of-way. Concho will have the spill site sampled to delineate any possible contamination from the release and we will present a remediation work plan to the NMOCD for approval prior to any significant remediation work.
