The commingled oil and gas production from the wells detailed above shall be measured and sold at the Hatfield State Well No. 5 central tank battery (CTB), located in Unit K, of Section 8, Township 17 South, Range 29 East, NMPM, Eddy County, New Mexico.

The Hatfield State Well No. 1, and Hatfield State Well No. 3 have common ownership; therefore oil and gas production from these wells shall be metered together along with testing, before commingling. The Hatfield State Well No. 2, Hatfield State Well No. 5, Hatfield State Well No. 7, Hatfield State Well No. 8, Hatfield State Well No. 9, Hatfield State Well No. 10, and Hatfield State Well No. 12 have common ownership; therefore oil and gas production from these wells shall be metered together along with testing, before commingling. The allocation meters shall be calibrated semi-annually in accordance with Rule 19.15.12.10.C (2) NMAC.

This installation shall be installed and operated in accordance with the applicable Division Rules. It is the responsibility of the producer to notify the transporter of this commingling authority.

The operator shall notify the Artesia District office of the Division prior to implementation of the commingling operations.
