The release was caused by a hole in 4" gas line; gas released was ignited by static electricity from nearby power lines. This created small fire and melted 4" water line next to it. There was impact to the nearby pasture. The lines were isolated to stop gas and water.

Describe Area Affected and Cleanup Action Taken.*

An area approximately 30' x 50' was impacted in the pasture near the flowline. Concho will have the spill site sampled to delineate any possible contamination from the release and we will present a remediation work plan to the NMOCD for approval prior to any significant remediation work.
