Re: Application of Encana Oil & Gas (USA) Inc. for administrative approval of a 160-acre, more or less, non-standard spacing unit in the Basin Mancos Gas Pool and approval of an unorthodox well location in the Basin Mancos Gas Pool for its Lybrook G31-2307-02H well in the N/2 of Section 36, Township 23 North, Range 8 West, San Juan County and the NW/4 of Section 31, Township 23 North, Range 7 West, N.M.P.M., Sandoval County, New Mexico.

Dear Ms. Bailey:

As reflected on **Exhibit A** (Form C-102), Encana Oil & Gas (USA) Inc. (OGRID No. 282327) seeks to drill its **Lybrook G31-2307-02H** well and dedicate it to a 481.24-acre spacing and proration unit within the Basin Mancos Gas Pool (Pool Code 97232). This well will be drilled from a surface location 1379 feet from the North line and 2401 feet from the East line (Unit G) of Section 31, Township 23 North, Range 7 West, Sandoval County, to a bottom hole location 1340 feet from the North line and 330 feet from the West line (Unit G) of Section 36, Township 23 North, Range 8 West, San Juan County, New Mexico.

As shown on Exhibit A, the first perforation for this well is expected to be 340 feet from the West line and 1,340 feet from the North line of Section 36, while the last perforation is expected to be 2,990 feet from the East line and 1,340 feet from the North line of Section 31. Since the Basin Mancos Gas Pool requires wells to be located no closer than 660 feet from the outer-boundary of the proposed spacing unit, this well will encroach on the spacing and proration units to the East and the West. Encana seeks an unorthodox location for this proposed well to allow for efficient well spacing and prevent waste of a productive reservoir.

Enclosed as **Exhibit B** is a land map depicting the proposed spacing unit in relation to the adjoining spacing units and the owners in the affected leases. This exhibit reflects that the proposed spacing unit adjoins the Alamito-Gallup Pool to the South, which is subject to 40-acre spacing, and is comprised of a single Indian allottee lease (BIA 1403-1949). In order to allow this single Indian allottee lease to be developed independently of the adjacent leases, Encana



seeks the creation of a 160-acre non-standard spacing and proration unit comprised of the NW/4 of Section 31 to form a 481.24 acre spacing unit and project area for the proposed well. Encana intends to develop the E/2 of Section 31 with two standup horizontal wells, which have been permitted under API Nos. 3004321210 and 3004321211.

Enclosed as **Exhibit C** is a list of the parties affected by the non-standard location and the creation of a non-standard spacing unit. It includes not only the affected lessees (Dugan, WPX and Oxy) but also the affected Indian allottee owners. A copy of this application with all attachments has been sent by certified mail to all parties advising them that if they have an objection it must be filed in writing with the division within 20 days from the date the division receives this application. A courtesy copy of this application has also been sent to the New Mexico State Land Office, the Bureau of Land Management, and the Federal Indian Mineral's Office.

Your attention to this matter is appreciated.

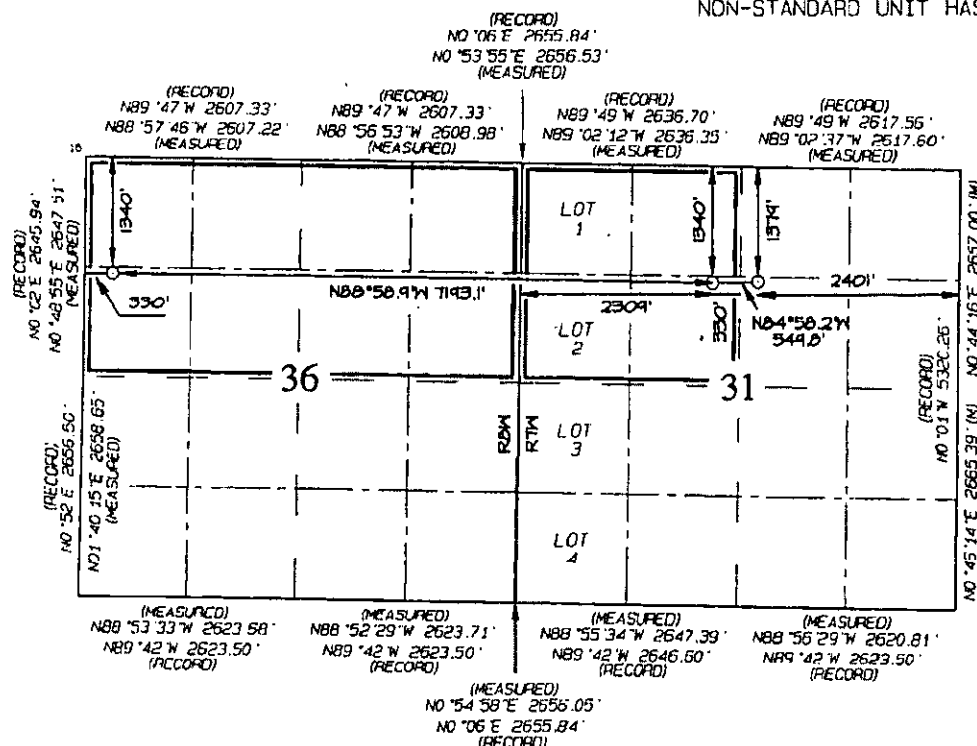

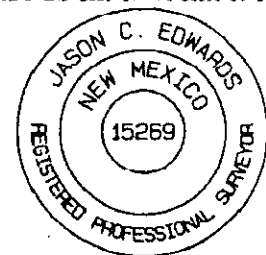

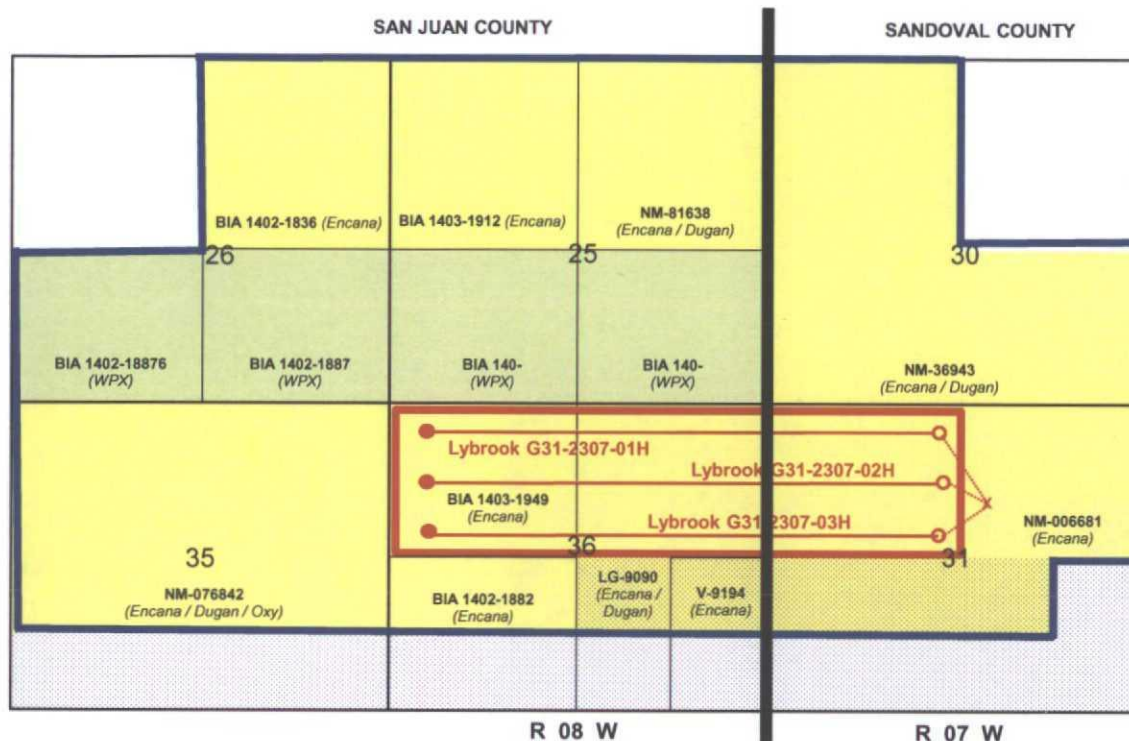
