Describe Cause of Problem and Remedial Action Taken.*

The fire is believed to have started in the main production heater treater and spread to the other heaters and separators. No tanks were involved. Flowlines were also destroyed. There was a release of approximate 350 bbls of liquid (combination of oil and water) but there is no way for us to determine the amounts of each as the fluid burned during the fire.

Describe Area Affected and Cleanup Action Taken.*

Soil samples have been taken. Approximately 2' of material will be removed and hauled to disposal. Once the material has been removed, the pad will be rebuilt with a 20 mil liner installed. The remaining impact will be left in place, and will be addressed after the battery has been rebuilt.

We had Diversified take a composite sample of the areas of SP-2 & SP-3, and ran the PID. The reading that we got back was 69.4, which is below the acceptable level (100). We have removed approximately 2' in the areas of SP-2, SP-3, and some of SP-5. The liner is in the process of being installed, and the pad will be rebuilt. The area is to be expanded to approximately 150' x75' south of where the berms divided the tanks and the heater treaters. The areas of SP-1, SP-5, & SP-6 will be addressed once the location has been put back into service. After the location has been put back into service, we can meet on location to discuss the best way to proceed with the remaining areas to be remediated. If there is anything else that you need or that we can do for you, let us know. Thanks
