The production tank had a gasket leak, causing the release. Vacuum truck(s) and roustabout crews were called.

Describe Area Affected and Cleanup Action Taken.*

An approximate area of 20' X 40'. Problems with the gasket were corrected and a vacuum truck recovered 94% of the released fluid (17 B/C). Impacted gravel (to include the remaining 1 B/C not vacuumed up) was excavated /hailed to a NMOCD approved facility. **Depth to Ground Water: <50' (approximately 20', per ChevronTexaco Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 20. Based on 94% of the released condensate recovered and all problems with the gasket resolved, Yates Petroleum Corporation requests closure.**
