On March 30, 2015 9:30 AM the Lease Operator noticed over spray in the pasture near the TNT 6 Fed Com 1, upon further investigation he discovered the poly line going from the TNT 6 Fed Com 1 to the TNT 6 Fed Com 2 had possibly been shot and caused a release in the pasture of 1/2bbl mixed oil and produced water.

Describe Area Affected and Cleanup Action Taken.*

The affected area is approximately a 100x100 area in the pasture located northwest of the lease road leaving the TNT 6 Fed Com 1. The surrounding vegetation will be pressure washed with Dawn soap.
