The project area for these wells include the entire Section 35, Township 19 South, Range 25 East, NMPM, Eddy County, New Mexico.

The commingled oil production from the wells detailed above shall be measured and sold at the Noose Federal Well No. Com. 10H central tank battery (CTB), located in Unit O, of Section 35, Township 19 South, Range 25 East, NMPM, Eddy County, New Mexico.

The commingled gas production shall be measured and sold at the Grave Digger Federal Com. Well No. 1H central tank battery (CTB), located in Lot 4, of Section 2, Township 20 South, Range 25 East, NMPM, Eddy County, New Mexico.

The oil and gas production for the wells shall be continuously metered before commingling. The allocation meters shall be calibrated quarterly in accordance with Rule 19.15.12.10.C (2) NMAC.

This installation shall be installed and operated in accordance with the applicable Division Rules. It is the responsibility of the producer to notify the transporter of this commingling authority.

The operator shall notify the Artesia District office of the Division prior to implementation of the commingling operations.

This Division Order supersedes Division Order CTB-732, issued on October 8, 2014.

This approval is subject to like approval from the Bureau of Land Management before commencing commingling operations.
