The project area for these wells include the S/2 N/2 of Section 5, S/2 of Section 5, and NE/4 NE/4 of Section 8, Township 23 North, Range 8 West, NMPM, San Juan County, New Mexico.

The commingled oil and gas production shall be measured and sold at the Chaco 2308-04L Well No. 284H Central Tank Battery (CTB) located in Unit L, Section 4, Township 23 North, Range 8 West, San Juan County, New Mexico.

Oil and gas production from each well shall be separately metered before commingling with production from other wells. The allocation meters shall be calibrated quarterly in accordance with Rule 19.15.12.10.C (2) NMAC.

This Administrative Order supersedes PLC 388-A, issued on April 17, 2014 for the Warner Caldwell Well No. 1A only.

The operator shall notify the transporter of this commingling authority.

The operator shall notify the Aztec district office of the Division upon commencement of commingling operations.
